A trust allows you to plan for much more than simply the transfer of assets after your death. A trust allows you to plan how you will care for yourself during a period of incapacity. A trust can be used to provide for children and grandchildren. You can also use trusts to reduce your estate tax burden. Used properly, a trust will allow your estate to pass without resort to the probate process and protect your confidentiality with regard to your final wishes. There are many different types of trust. For example, you can establish a charitable trust, business trust, cabin trust, or a special needs trust for a disabled child to name just a few.
